ACIC provides **Information Technology** to criminal justice agencies through the crime information system. ACIC also administers the state's Computerized Criminal History (CCH) file, the Sex Offender Registry, the Crime Victim Notification System, the Uniform Crime Reporting program, the National Incident Based Reporting System and the Office of Crime Prevention and provides technical assistance to local law enforcement on record systems and communication.

The ACIC network now includes 203 criminal justice agencies in 288 different locations, with over 1,895 access devices attached. In 2001 over 34 million transactions were processed through the ACIC system. ACIC also provides access to systems in the other 49 states and to the NCIC system operated by the FBI. Use of ACIC has steadily increased over the past 30 years, with the most dramatic increase being in the past three years due to mobile computers. The cost for processing transactions is directly related to volume. ACIC uses the DIS mainframe computer and pays a monthly fee to DIS based upon volume. *The volume generated by law enforcement agencies using ACIC determines the cost charged to ACIC by DIS. This means that the cost is basically outside of the control of ACIC.*

The "ACIC2" system upgrade was completed in 2001. This process included converting 400 dumb terminals to intelligent workstations, a new higher speed data network, new relational database files and a message switching processor dedicated to ACIC. This new ACIC2 will support all the features and functions of the new FBI NCIC2000 system. State and local government in Arkansas are sharing the cost of ACIC2.

ACIC has three main budget priorities for the next biennium:

1. Additional funding for network and system operating costs is critical. ACIC has increased the fees charged to its users by 34 percent in the past two years in an attempt to cover rising costs. This was necessary because additional state funding was not available. Further increases to our users will be nearly impossible, given the financial situation of most local user agencies.
2. ACIC is requesting the addition of three new positions: (1) Systems Programmer and (2) Information System Agents.

The System Programmer is necessary to aid in the support of our many PCs, servers, laptops, printers and field

equipment. Our current staff is unable to perform all the programming functions that are mandated by federal and state government regulations.

One of the Information System Agents would be assigned to the National Incident Based Reporting System, which is the crime reporting system developed by the FBI. Arkansas is completing the process of converting to this more detailed form of reporting. If Arkansas is to be successful in the implementation and continuation of the NIBRS project, ACIC must have an employee assigned to this program.

The other Information System Agent would be assigned to the Sex Offender Registry Program. ACIC is mandated by state legislation to maintain the Sex Offender Registry program. We must have a position assigned to this program to fulfill and properly maintain the Sex Offender Registry program, thereby enabling ACIC to be compliant with legislation.

The Arkansas Crime Information Center is responsible for the state's law enforcement and criminal justice information management system. The Agency's total request including Base Level is \$5,803,984 in FY04 and \$5,867,048 in FY05.

Section 8 of Act 1027 of 2001 requires the Arkansas Crime Information Center to certify to the Chief Fiscal Officer of the State, the amount of unexpended funds and appropriation in the Crime Information Center Fund (MJA) resulting from the reimbursement to the Arkansas Crime Information Center by municipal, county, state or federal governments for teleprocessing services. Any such balance of funds and appropriation shall be carried forward and made available for the maintenance, operation, improvement and other necessary expenditures in providing teleprocessing services to such municipal, county, state or federal agencies served by the Arkansas Crime Information Center. In accordance with the provisions of Act 1027 of 2001, Arkansas Crime Information Center has certified \$190,422.50 in unexpended funds and appropriation. As further required by Act 1027 of 2001, this carry forward amount is hereby reported to the Arkansas Legislative Council/Joint Budget Committee.

The Base Level request includes a 2.7% salary increase each year over the FY03 salary levels for all incumbents plus associated increases in Personal Services Matching. Included in Personal Services Matching is a \$33 per month increase in the monthly contribution for State employee's health insurance for a total state contribution of \$280 per month per budgeted employee.

The Agency is requesting the following change levels totaling \$1,596,637 in FY04 and \$1,602,778 in FY05.

Salaries and Matching: Restoration of 4 positions as well as 3 new positions and Reclassification of R132 Planning Specialist.

Operating Expenses: \$71,703 each year of the biennium for rent, utilities and office supplies.

Travel and Conference: \$30,000 each year of the biennium to send employees to training conferences.

Capital Outlay: \$100,000 each year to replace furniture and computers.

Professional Fees & Services: \$144,000 each year of the biennium to continue the Jailnet and VINE programs.

Data Processing: \$1,000,000 each year to support DIS fees.

The Executive Recommendation provides for Base Level and reduces the Professional Fees & Services to \$550,000 and increases Data Processing by \$106,000 and provides for \$20,000 Capital Outlay for each year of the biennium.

The Executive Recommendation provides appropriation only.

The Integrated Justice Project implements an electronic data sharing system among agencies and county offices. This project develops and applies data standards and installs new case management systems to participating agencies.

The Integrated Justice Project was established in FY02 and budgeted in FY03 by a miscellaneous federal grant.

The Base Level request includes a 2.7% salary increase each year over the FY03 salary levels for all incumbents plus associated increases in Personal Services Matching. Included in Personal Services Matching is a \$33 per month increase in the monthly contribution for State employee's health insurance for a total state contribution of \$280 per month per budgeted employee.

The Agency requests a change level in Salaries and Matching of \$188,087 in FY04 and \$192,894 in FY05 for the continuation of three positions established by miscellaneous federal grant in FY03.

The Agency requests change levels in Operating Expenses, Travel/Conferences, Professional Fees & Services totaling \$414,406 in each year to continue the Integrated Justice Project into the new biennium.
