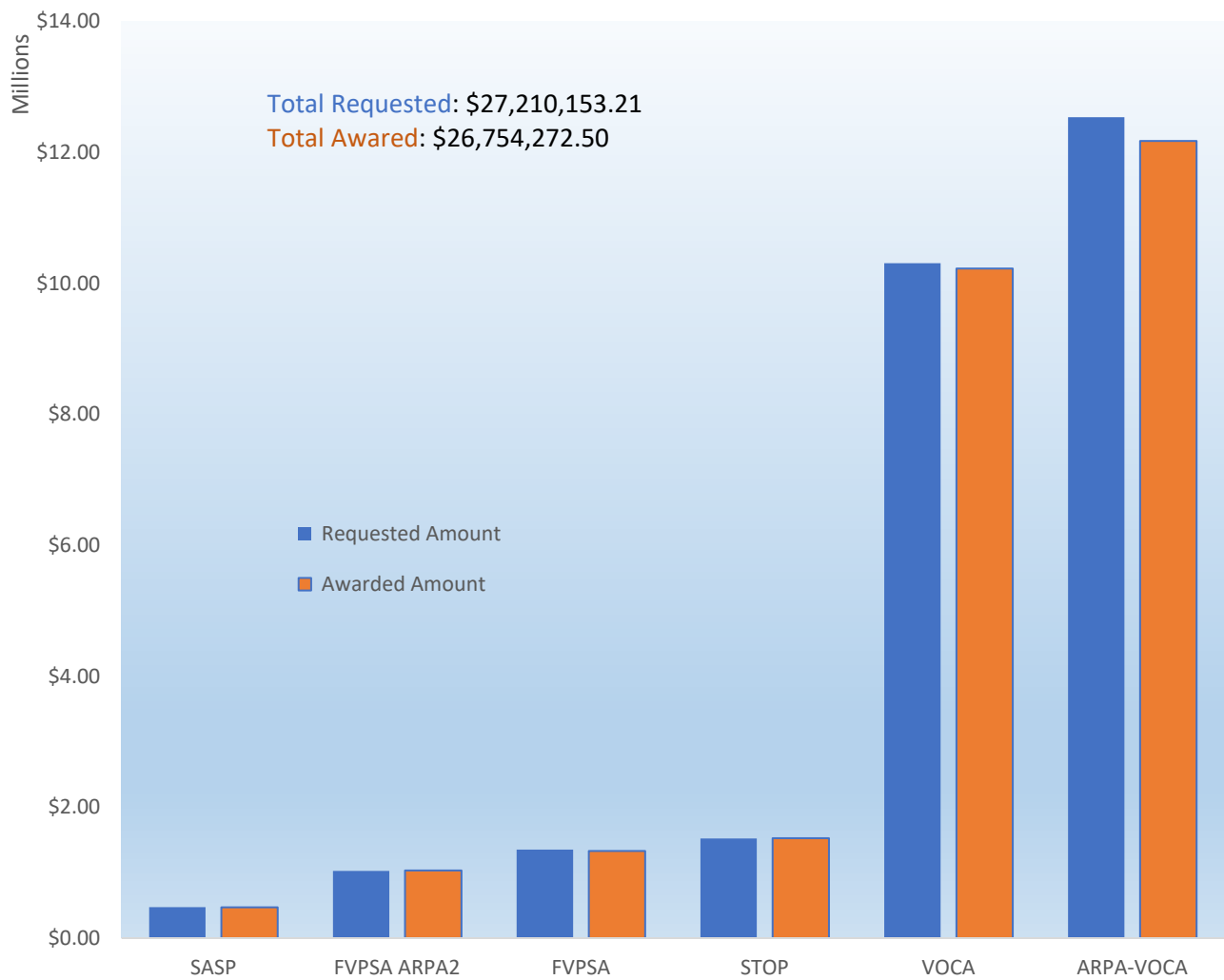


# 2023 VJA Subgrant Award

The office of Intergovernmental Services received a total of 162 applications from 128 different organizations for the 2023-2024 grant cycle. A total of 153 applications was awarded a requested amount of \$27,210,153.21.
