**ORDER**

Pursuant to authority contained within Arkansas ABC Rule 2.19, the following Order is promulgated and adopted to set forth the sizes of containers and combinations thereof, in which all sales of all beverages for consumption off premises shall be made:

- (1) Approved sizes and combinations for the sale of malt beverages for consumption off premises:
  - a. One  $\frac{1}{2}$  barrel container of 13.2 or 13.5 gallon container;
  - b. One  $\frac{1}{4}$  barrel container or 7.9 gallon or 10.8 gallon container;
  - c. One  $\frac{1}{8}$  barrel container or 20 liter or 25 liter or 6.6 gallon container;
  - d. One  $\frac{1}{8}$  barrel container;
  - e. One 5 liter container or  $2\frac{1}{4}$  gallon container, or 3 liter container, or 1.26 gallon container;
  - f. One 64 oz. or 2 liter container;
  - g. One 40 or 45 oz. or 46.5 oz., 50.7 oz. or 59.2 oz. container or 1.75 liter container;
  - h. One 32 oz. or 1 liter container;
  - i. One 16.0 oz., 16.9 oz., 18 oz., 18.5 oz., 18.6 oz., 18.7 oz., 19.25 oz., 20 oz., 21.4 oz., 21.6 oz., 22 oz., 22.3 oz., 22.4 oz., 23.5 oz., 24 oz., 24.3 oz., 25 oz., or 25.4 oz. container;
  - J. 18, 12, 8, 9, 6, 4 or 2 pack of any container of 16 oz;
  - k. 36, 32, 30, 24, 20, 18, 15, 12, 8, 6, 4 or 3 pack of any container of 15.2 fl. oz. or less. No beer may be sold in any container less than 7 oz. In no event is any authority hereby granted for any single bottle or can sales for any container of less than 16.0 oz. in size.

- (2) Approved sizes for liquor;
  - a. None less than 50 ml.
- (3) Approved sizes for wine except light wine:
  - a. None less than 187 ml.
- (4) Approved sizes for Light Wine:
  - a. None less than 187 ml for holders of a retail liquor permit or Grocery Store wine permits; however, 50ml containers are allowable if it is packaged with another container and the entire package contains at least 187 ml of light wine. The products must be sold in their original factory sealed package. You may not disassemble the package and sell the less than 187 ml sized container individually or in any other combination.
  - b. In no event is any authority granted for any single container sales of less than 16.9 ounces by the holder of a retail beer - off premises permit. Three (3) is the minimum package size allowed for less than 16.9 oz.
