

The Arkansas Tobacco Control Board met on Thursday, October 03, 2024, for its monthly meeting in the Main Street Mall Building, located at 101 E. Capitol Avenue, Little Rock, Arkansas, beginning at 10:00 a.m. in Suite 119. There were six (6) Board members present.

# CALL TO ORDER.

• Chairman Gary Proffitt called the ATC Board meeting to order and opened the meeting welcoming the guests and staff.

# **BOARD MEETING MINUTES**

Chairman Gary Proffitt requested a motion to approve the board meeting minutes from September 12, 2024. A motion was made by Mr. David Hendrix, Jr. and seconded by Mr. Kerry Lott to approve the September 12, 2024, minutes. It passed with six (6) yes votes and zero (0) opposing votes.

**Violations:** (1) Sell to Minor - A.C.A. § 5-27-227(A)(1) (2) No Server Awareness Form – ATC Rule 4.1

In light of the evidence and testimony submitted before the Board, a motion was made by Dr. Shabbir Dharamsey and was seconded by Mr. David Hendrix, Jr. to increase the penalty to \$ 2,000.00 from the recommended penalty of \$1,400.00 civil penalty and keep the ten (10) day permit suspension for the violation of Sell to Minor - A.C.A. § 5-27-227(A)(1). For the violation of ATC Rule 4.1., increase the civil penalty from the recommended \$100.00 to \$1,000.00. The motion passed with six (6) yes votes and zero (0) opposing votes.

A motion was made to accept the Accepted Offers of Settlement by Mr. Kerry Lott and seconded by Dr. Shabbir Dharamsey. The motion passed with six (6) yes votes and zero (0) opposing votes.

A motion was made to accept the Default Offers of Settlement by Dr. Shabbir Dharamsey and seconded by Mr. Kerry Lott. The motion passed with six (6) yes votes and zero (0) opposing votes.

#### **ENFORCEMENT ACTIVITY**

 CID Director David Potter introduced our new Budget Specialist, Niharika Parsa, and reported for following results for compliance checks.

Results for Inspections for the month of September 2024, with 28 inspections totaled 10 violations = 25 %.

# **FDA ACTIVITY**

Jody Dotson reported for the month of September 2024 FDA Agents completed 208 routine inspections with 9 potential violations resulting in a 4.33 % violation. FDA Agents completed 46 follow-up Inspections with 0 potential violations resulting in a 0 % violation rate for the month of September 2024.

#### LEGAL UPDATE

ATC Attorney Cameron Coker updated the Board on the law regarding wholesalers and retailers, under the same ownership, being permitted at the same location in response to a question posed at the previous meeting. There is no legal prohibition against wholesalers and retailers being permitted at the same location as long as their ownership is exactly the same. Previous directors and attorneys have, as a policy matter, not allowed retailers and wholesalers under the same ownership to be permitted at the same location while others have. Moving forward it will be ATC policy to allow this practice while allowing retailers and wholesalers, under the same ownership, who have been permitted at separate locations to keep their existing permits.

#### ADJOURNMENT
