## **Project Safe Neighborhoods – Eastern District Notice of Available Funds**

**Project Period: October 1, 2024 – September 30, 2025**

**Funding Amount: \$245,351.40**

### **Description:**

The State of Arkansas, Department of Finance and Administration – Office of Intergovernmental Services (IGS) announces the availability of Project Safe Neighborhoods funding under the U.S. Department of Justice’s Office of Justice Programs (OJP) Bureau of Justice Assistance (BJA) Justice Assistance Grants (JAG) Program. Program participants should carefully review the required assurances and special conditions of the proposed award, as well as all reporting requirements. The timeframe of the grant is **October 1, 2024 – September 30, 2025**.

### **Eligible Entity:**

Eligible entities are limited to law enforcement units that operate within the United States Attorney’s Office – Eastern District of Arkansas. Entities must have and maintain an active UEI registered in SAM.gov.
