

Issuance of a driver's license or identification card in the State of Arkansas will cancel any driver's license or identification card issued in another state.

<u>General Requirements-</u> Applicants that request a change in name, date of birth or social security number must provide documents to link the change from the previous information to the new information. Documents printed from an online account may be accepted. A post office box or business address will not be accepted. Birth cards or hospital birth certificates will not be accepted. Proof of legal presence for U.S. Citizen's and Non-U.S. Citizen's must be original or a certified document.

<u>Residency Documents:</u> Children may use residency documents of their parents accompanied with their birth certificate.

Husband/wife may use residency documents of their spouse accompanied with their marriage certificate.
