CIGARETTE WHOLESALERS AND STAMP DEPUTIES - CALENDAR YEAR 2024

Per AR Code Ann 26-57-236, the Director of the Department of Finance and Administration shall furnish cigarette tax stamps to licensed wholesalers through stamp deputies. An appointment and commission as a stamp deputy by the Director is effective for one year. Manufacturers, importers, and sales entity affiliates are entitled to rely on the list when selling cigarettes.
